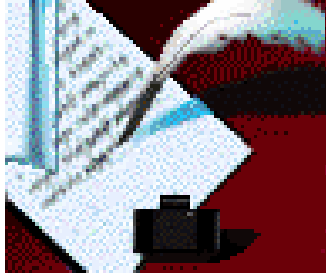

NEW DOCUMENTS PENDING

Revisions on the new CLWII Indentures will be final soon. When finalized, these new documents will be forwarded to each and every homeowner for their review.

If you recall, the trustees posted a notice in the previous issue of Country Times regarding the expiration of the current CLWII Indentures of Restriction. The original document was valid for a period of 30 years and is scheduled to expire this year. If we do not approve a new document, the previous document self-renews for another 10 years.

We have asked for input from all homeowners and some of you have responded already. If you would like to voice your input in person, please attend the next trustee meeting.

You will soon be asked to compare the original document against the revised document, and also asked to cast a vote prior to a predetermined date. Please be watching your mailbox for additional notices.

- BUSINESS SUMMARY -

Clubhouse & Grounds Update

Heat buildup inside the clubhouse has been remedied. Final stages of construction are under way for the installation of 2 wall air conditioning units in the main room.

The 5-1/2 ton central air conditioning unit could not keep up with the demands placed on it during the hot days of summer. Three pools so close to the building cause higher-than-normal humidity levels. The downstairs doors remain open to the pool area and clubhouse renters are opening the front doors frequently. These combined factors allowed more hot, humid air into the building and the result was a torrid zone in the main room.

The central a/c thermostat will still be used, preferably set between 70 and 75 degrees. As an adjunct, the two wall a/c units can be turned on to help boost the amount of cold air upstairs.

If you are renting the clubhouse during August and September, please let us know how this new system works for you.

Drainage Systems

Sloped areas between the pool, tennis courts and parking lot have been regraded, and drainage systems were installed to prevent water run-off from pooling and creating mud holes. Additional work had to be undertaken to make these systems operate more efficiently.

Underground drain pipes were added to and lengthened. A new drain was installed between the parking lot and the sidewalk leading to the pool. This seems to be effectively catching the bulk of water run-off from the parking lot.

Playground Update

In the previous issue of this newsletter, we alluded to some of the delays we experienced during the playground expansion project. We are now pleased to

to report that the project is nearing completion with the refurbishing of some of the older pieces.

The playground area was enlarged to add new equipment. Repositioning the softball backstop was necessary to allow for the extra space requirements. In surveying the backstop, we realized it, too, had to be replaced.

The overall finishing touch was provided by the addition of 134.3 tons of sand.

- Trees -

Trustees are responsible for arranging for the removal of dead trees on common ground areas.

Typically, dead trees in the middle of a wooded area are allowed to fall and decompose naturally. However, if a dead tree poses a danger to your property or dwelling, please notify us immediately.

Recently, a few homeowners have been surprised by a dead tree falling on their property after heavy storms hit the area. Then, there was a long delay in scheduling the tree removal because our tree service

was inundated with many other emergencies created by the storms.

Please contact us at 636-225-0930. We will arrange to come to the property and verify that the tree is on common ground before we contact our tree service.

Live tree trimming is the responsibility of the homeowner.

Fencing and Architectural Control

For approval of home additions, alterations, or new fencing, please submit plans or drawings, along with a copy of your plat map, indicating placement of addition or alteration or fence. Be sure to include your name, address, and phone number.

Place paperwork in an envelope addressed to Eric Ruegg, and place in the mailbox in front of the clubhouse at 851 Country Stone Drive. Or, you may come in person to our monthly business meeting on the first Monday of each month. This may be necessary in the event we need a sample of the proposed material.

Renters are required to clean premises after use. Trash bags, paper towels, and vacuum cleaner are provided.

For **any** pool rental, you must contact us no later than 3 weeks before rental date. Additional hourly costs charged by the pool company will be determined by the number of

lifeguards required for your party. All pool rentals must end by 11:00 p.m.
